### **Terms and Conditions**

#### *Entry*

1. Information on how to enter and prizes forms part of these Terms and Conditions. By participating in the Promotion, you agree to be bound by these Terms and Conditions.
2. The Promotion commences at 12:01am AEST on 17 September 2026 and ends at 11:59pm AEDT on 28 October 2026 ("Promotional Period").
3. You must be aged 18 years or over to enter. Entry is open to Australian residents. Employees of the Promoter and their immediate family and other persons associated with the Promotion are ineligible to enter.
4. To enter online, go to [bhg.com.au/fantasticfurniture](https://bhg.com.au/fantasticfurniture) during the Promotional Period and follow the prompts to the Promotion entry page. Complete and submit the online entry form, including your first name, surname and email address, and answer in 25 words or less: "Tell us which room in your house requires a makeover the most and why."
5. Multiple entries are permitted, subject to each entry being submitted separately and in accordance with the entry requirements. Each entry must be substantially unique.
6. An entry must be complete, legible, lawful and submitted during the Promotional Period. The Promoter may deem inappropriate entries ineligible and discard them.
7. The Promoter reserves the right to verify the validity of entries and entrants, including identity, age and place of residence, and to disqualify any entrant who does not comply with these Terms and Conditions or tampers with the entry process.
8. Any costs associated with entering the Promotion, including data costs, are the entrant's responsibility.

#### *Judging and award of prize*

9. The Promotion is a game of skill; chance plays no part in determining the winner. Each valid entry will be individually judged based on its literary and creative merit and the originality of the response. The judges' decision will be final and binding. No correspondence will be entered into.
